I agree to pay a **\$100 water deposit** before water will be transferred into my name. I understand that if my water bill is then paid, with **no delinquents for 12 consecutive months**, the Deposit will be refunded to me in full. **No refund will be paid to me if I fail to pay the water bill on time every month.**

If service is discontinued for nonpayment of fees charges, or fee of violation of any Ordinance, a fee of \$100 shall be paid to the City Clerk in addition to the rates or charges then due before such service is restored. If payment is made to the Superintendent of Superintendent's designee at the time of disconnection, there shall be a charge of \$100. If any such service charge is not paid within (60) days from the due date, the same shall constitute a lien upon the premises served by said municipal system, which said lien shall be collected in the same manner as taxes.

GARBAGE COLLECTION FOR THE CITY OF BRITT

Current garbage collection, within City limits, is with Absolute Waste Removal. There are no alternative vendors at this time. At the time you complete your Water/Sewer application at City Hall, you can order your garbage and recycling totes.

Collection days are as follows: East side and North of the Highway is every Thursday. The West side of town is every Friday. Recycling Service is every week and will be picked up the same day as your garbage pick-up.

Please note- Title VI, Chapter 4 of the Britt City Code of Ordinances states:

Section 6-4-3: All households shall be bound by the current collections contract as agreed to by and between the City Council and the contracted waste hauler Absolute Waste Removal.

Sections 6-4-4: No person shall collect garbage or rubbish except such person's unless by contract with the City of Britt. This only pertains to residential. Commercial has no such limitations.
